9:45 a.m. Species Assessment Group Update

- At next two Council meetings SAG coordinators will present most have already presented, but then we paused to ask experts to weigh in on SAG recommendations. Now SAGs will present their recommendations and anything the species experts differed on.

- Fish and crayfish group only focused on mosquito fish in past, but since then
 there have been concerns on Asian swamp eel. Bob Stroess raised this issue and
 talked with Fisheries want to have this species listed by name specifically
 (genus). Species is in the food trade.
- Would be nice to have update from Bob Stroess and Liz Tanner at a future meeting.
- Questions about adding Golden oyster mushroom. Tara can talk with Andrea Diss-Torrance about it. Could come up at a public hearing, so we should prepare for that.

10:15 a.m. Agency Updates/Other Business

Drew Feldkirchner (DNR) – Don't have much other than tried to get more funding for this work. Submitted budget proposal last two rounds but has been taken off the table for now. Mackenzie hired and has started as new Invasive Plant Specialist. Little brown bat show modest increase in populations – maybe slow rebound from white nose syndrome. Northern long-eared bat is now endangered on the Federal level, not doing well.

Brian Kuhn (DATCP) – Added Douglas County to spongy moth quarantine. Worked with DNR Forest Health staff to get quarantine in place. This is a slow the spread program, but won't stop it. Duluth will be treating some areas of the city this year for spongy moth. Expect Minnesota to have challenges from forest products industry about spongy moth quarantines. DATCP spongy moth treatments to begin week of May 22nd. Filled 4/5 permanent vacancies, hired 20-25 seasonal LTEs for trapping spongy moths. Filling supervisory position has been challenging. Moving office (same building, different floor) this week and next week. Met Secretary Payne with DATCP secretary – Secretary Payne started with DATCP as an LTE back in the day. Central Plant Board meeting last week went well. National Plant Board meeting will be in Little Rock, Arkansas in August.
