## WELCOME!

**Muskellunge Lake Campground,** (better known as Musky Lake), sites 301-382, is in the central portion of the Northern Highland-American Legion State Forest on the southeast corner of Big Muskellunge Lake. Musky Lake offers an easy turnaround boat landing with extra parking. Fishing holds strong at Big Muskellunge Lake with 897 acres of fishable waters of musky, panfish, largemouth bass and walleye angling opportunities. The campground is located next to Crystal Lake and the Crystal Lake Campground. A sandy beach for swimming can be found at nearby Crystal Lake picnic area.

## **TICKS AND LYME DISEASE**

Ticks are common across Wisconsin and may be found in the forest. Lyme disease is an illness that can be spread to humans from the bite of a tick. You can protect yourself against Lyme disease and other tick-borne diseases by practicing these tips:

- Stay in the middle of trails.
- Apply insect repellent on exposed skin and over clothes.
- Wear light-colored clothes to spot ticks more easily.
- Do a full-body tick check after outdoors activities.

#### **AMENITIES**

- **Campsites Available:** 81 (#318 is Americans with Disability Act [ADA] compliant)
- **Reservable Sites:** All sites in the campground are reservable.
- **Double Sites:** 336-337, 362-363, 381-382
- On-site campground host (Memorial Day through Labor Day)
- Direct access to Heart of Vilas County Paved Bike Trail
- Pet swimming and picnic area at Muskellunge Lake (leash required)
- Boat landing and limited parking
- Sanitary disposal station nearby at Crystal Lake Campground
- Trash and recycling stations
- Three vault toilet buildings
- One building with flush toilet and showers (ADA compliant)
- Three hand pumps for drinking water
- Firewood for sale nearby at Crystal Lake Visitor Station
- Paved campground roads
- State Parks and Forest Admission Sticker required for camping

#### **VEHICLE STICKER**

A vehicle admission sticker is required on all motor vehicles within the campgrounds at Northern Highland-American Legion State Forest.


#### **CAMPGROUND RULES**

- All campers must make a reservation before setting up on any site.
- **Checkout Time:** Must vacate site by 3 p.m. on the last day of the permit.
- Campground/Day-use Areas and Closing Time: Campground closed to nonregistered campers 11 p.m. to 6 a.m.
- **Pets** must be on a leash at all times and not left unattended.
- **Noise** may not interfere with the enjoyment of the forest by others.
- **Generators** may be used from 10 a.m. to 5 p.m.
- **Camping Party:** A "non-family group" may not exceed six people. A "family" is limited to parents with their dependent children and not more than two guests.
- A State Parks and Forest Admission Sticker is required for camping.
- For complete rules and regulations, see Chapter NR 45, Wis. Admin. Code, or contact DNR Law Enforcement.
