SUBJECT: Land Acquisition and Monetary Donations – Leola Marsh Wildlife Area and Central Wisconsin Grassland Conservation Area – Adams County

FOR: JUNE 2022 BOARD MEETING

TO BE PRESENTED BY: James W. Lemke, Real Estate Section Chief

SUMMARY:

The department is requesting approval to acquire 520 acres of land located within the project boundaries of the Leola Marsh Wildlife Area (440 acres) and the Central Wisconsin Grassland Conservation Area (80 acres) from the Marie Petriken Revocable Trust dated May 11, 1998, for \$1,140,000.00, under authority provided in s. 23.09(2)(d), Wis. Stats., and ss. NR 1.40(2)(a) and 1.41(1)(a), Wis. Admin. Code. The subject property will be accessible to the public through CTH W, Apache Avenue and adjacent department-owned land to the south and north.

The acquisition will be financed with \$50,000 of donated funds from the Dane County Conservation League, \$250,000 of donated funds from The Nature Conservancy (TNC), \$240,000 from the Warren Knowles-Gaylord Nelson Stewardship Program pursuant to s. 23.0917, Wis. Stats., and \$600,000 from the US Fish and Wildlife Service Pittman-Robertson (PR) grant funds.

The proposed acquisition connects two separate department-owned tracts of land within the Leola Marsh Wildlife Area. Leola Marsh is managed as a grassland to the benefit of many grassland dependent species including state threatened and special concern species, including a population of greater prairie chickens (GRPC), a state threatened species. The subject property has supported a GRPC lek for several years. These leks are breeding grounds for GRPC and play an important role in their life history. If this property is acquired, this lekking area would be protected from potential future land use changes that may make it unsuitable for breeding grounds for this state threatened species.

Four hundred and forty acres of the property are currently in grazed grassland. The transition to habitat suitable to grassland dependent species would be minimal and would not require extensive department involvement. A well with electricity is operational on the property; if acquired, this well would be maintained and would increase the flexibility property managers have to manage state owned adjacent grasslands, utilizing conservation grazing.

The purchase of the subject property meets the objectives and acquisition goals of the Central Sand Plains Master plan, which is currently being drafted. Additionally, the Greater Prairie Chicken Species Management Plan which is also being presented to the NRB at this June meeting, has, as a goal, to increase the amount of grassland habitat that meets the needs of GRPC. Acquiring the subject property would be an important step to meeting the goals and objectives of both plans.

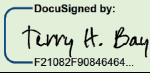
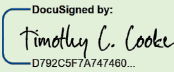
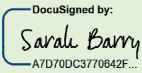
This area is very popular with the public for bird watching and other outdoor recreation including deer and turkey hunting and trapping which occur frequently on the Leola Marsh Wildlife Area. The property would be managed similarly to the Leola Marsh Wildlife Area which consists of developing, improving and maintaining a grassland habitat. If acquired, this property would add to the Leola Marsh Wildlife Area and Central Wisconsin Grassland Conservation Area, making available more land open to these and other suitable activities.

The subject will be open for all five nature-based outdoor activities, including hunting and trapping. The department recommends acquisition of this parcel to improve recreational opportunities and to help achieve wildlife management objectives for the Central Part of the State.

RECOMMENDATION: That the board approve the purchase of 520 acres of land for the Leola Marsh Wildlife Area and the Central Wisconsin Grassland Conservation Area for \$1,140,000.00. That the Board accept donations of \$50,000.00 from the Dane County Conservation League and \$250,000 from The Nature Conservancy towards the purchase. For both donations, that a certificate of appreciation be sent to the donors, and that an expression of appreciation be made a part of the official records of the Natural Resources Board.

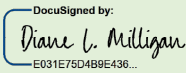

The purchase of the subject property meets the objectives and acquisition goals of the Central Sand Plains Master plan, which is currently being drafted. Additionally, the Greater Prairie Chicken Species Management Plan which is also being presented to the NRB at this June meeting, has, as a goal, to increase the amount of grassland habitat that meets the needs of GRPC. Acquiring the subject property would be an important step to meeting the goals and objectives of both plans.

This area is very popular with the public for bird watching and other outdoor recreation including deer and turkey hunting and trapping which occur frequently on the Leola Marsh Wildlife Area. The University of Wisconsin Stevens Point (UWSP) works with the department to provide public opportunities to view the prairie chickens' mating ritual on the leks as well. The property would be managed similar to the Leola Marsh Wildlife Area which consists of developing, improving and maintaining a grassland habitat. If acquired, this property would add to the Leola Marsh Wildlife Area and Central Wisconsin Grassland Conservation Area, making available more land open to these and other suitable activities.

The subject will be open for all five nature-based outdoor activities, including hunting and trapping. The department recommends acquisition of this parcel to improve recreational opportunities and to help achieve wildlife management objectives for the Central Part of the State.

3. LAND MANAGEMENT:

The 80-acre wooded parcel will be managed as part of the surrounding Central Wisconsin Grassland Conservation Area. This parcel is separated from the 440-acre parcel by a ditch. The department will install a culvert across the ditch to provide access for recreation as well as management. These wooded acres will be managed as such utilizing forestry practices.

This 440-acre parcel will continue to be managed as grassland in conjunction with the surrounding Leola Marsh Wildlife Area. The few large trees located on this parcel will be cut down. The existing well will aid in management in keeping the parcel as grassland.

Given a majority of the parcel's history of grass-based agriculture, minimal management would be needed to maintain the entire property in the desired open landscape. Much of this management would be focused on conservation agriculture practices in cooperation with a producer. We focus on adaptive management on the property; however, the general goal would be to disturb approximately one-quarter of this larger parcel a year (~110 acres) with mowing, grazing, and/or haying. Given similar management on the adjacent Leola Wildlife Area parcel, we estimate lease payments to be \$5-\$15 per acre when conservation grazing contracts are implemented and \$5-\$10 per acre when haying contracts are implemented. Mowing operations for maintenance and spraying to remove

invasive plant species would occur as needed.

Long term grassland maintenance will include grazing, haying, and mowing which should be able to maintain the habitat at a low net cost to the department. The initial projects and ongoing management costs will be funded using sharecrop funds as well as SEG/PR dollars.

4. FINANCING:

The \$1,140,000 acquisition will be financed with \$50,000 of donated funds from the Dane County Conservation League, \$250,000 of donated funds from The Nature Conservancy (TNC), \$240,000 from the Warren Knowles-Gaylord Nelson Stewardship Program and \$600,000 from the US Fish and Wildlife Service Pittman-Robertson (PR) grant funds.

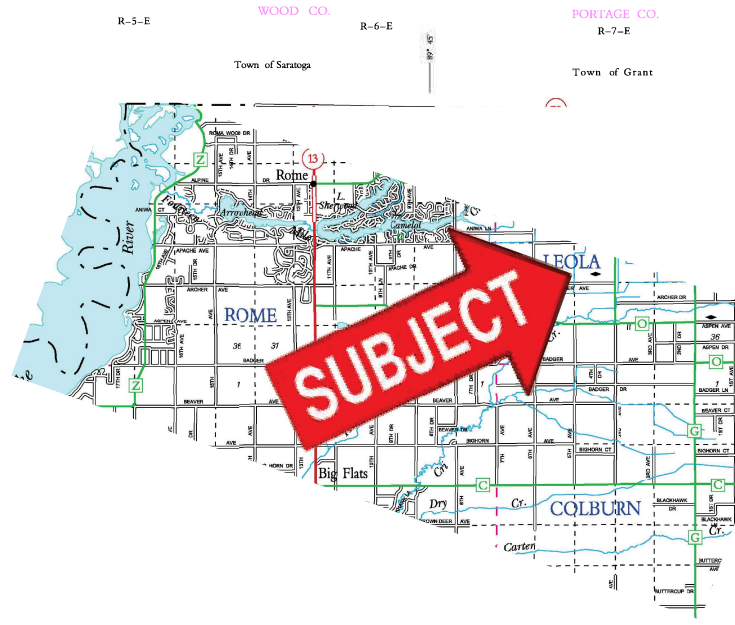
