SUMMARY:

These rule changes were included in the 2021 Wildlife Management Spring Hearing rules package and questionnaire. This rule package will modify regulations for hunting, trapping, and target shooting found in Ch's. NR 10 Game and Hunting and 45 Miscellaneous Fur, Fish, Game and Outdoor Recreation.

Specifically, these rules:

- 1. Allow falconry to take place on the Richard Bong State Recreation Area after the 2 p.m. closure.
- 2. Increase the time that cable restraints are allowed during regulated trapping seasons.
- 3. Return to a three-zone framework for mink and muskrats.
- 4. Allow the department to regulate target shooting on department properties in Columbia County.
- 5. Extend the date of the gray and fox squirrel seasons.

SUBJECT: Background memo on Board Order WM-18-20, relating to the 2021 Wildlife Management

spring hearing rule.

1. Subject of Proposed Rule:

The proposed rule addresses trapping restrictions, season frameworks, and uses allowed on certain department properties.

2. Background:

Annually, the department submits rule change proposals relating to hunting, trapping, and wildlife management. The statewide April spring fish and wildlife hearings are the traditional vehicle for citizen input. The origins of these rule change proposals are primarily from department staff specialists in the relevant bureaus and Conservation Congress advisory questions from prior years. Initiating the process promulgates rules recommended by the Conservation Congress fulfills a role the board and congress established in s. 15.34 Stats. All these proposals were reviewed by department staff prior to inclusion as proposals in this rule order. For details on each of the proposed rule changes, please refer to the attached spring hearing questions proposal (Appendix 2).

3. Summary of the rule.

These rule changes were included on the 2021 Wildlife Management Spring Hearing rules package and questionnaire. This rule package will modify regulations for hunting, trapping, and target shooting found in Ch's. NR 10 Game and Hunting and 45 Miscellaneous Fur, Fish, Game and Outdoor Recreation.

Specifically, these rules;

- 1. Allow falconry to take place on the Richard Bong State Recreation Area after the 2 p.m. closure.
- 2. Increase the time that cable restraints are allowed during regulated trapping seasons.
- 3. Return to a three-zone framework for mink and muskrats.
- 4. Allow the department to regulate target shooting on department properties in Columbia County.
- 5. Extend the date of the gray and fox squirrel seasons.

Public Input:

All of the department's proposals were supported statewide. The complete text of each question that was the subject of the April 8 hearing is attached as Appendix 1. The results of input on each



proposal, the department's recommendation, and the results of consideration by the Conservation Congress at its annual convention are summarized in Appendix 2.

In addition to the online and in-person input, the department received only three written comments during the official comment period. Two individuals wrote in opposition to of Wildlife Management rule questions number four with another individual opposing question five.

Modifications after Hearings:

After reviewing the public input and further discussing the rule proposals, the Wildlife Management program chose not to make any edits to the proposed rule.

4. How does this proposal affect existing policy?

All of the policies in this proposed rule are consistent with past board policies of regulating fish and game harvest for conservation purposes. The annual Spring Hearings, held virtually in 2021, serve as the traditional route for gaining public input on DNR rule proposals, as well as Wisconsin Conservation Congress and Natural Resources Board advisory questions that may become rule proposals in the future.

5. Has Board dealt with these issues before?

The statement of scope for this rule, SS 028-21, was approved by the Governor on February 26, 2021, published in Register No. 783A2 on March 8, 2021 and approved by the Natural Resources Board on April 14, 2021. The board approved the proposed questions at its February 24, 2021 meeting.

6. Who will be impacted by the proposed rule? How?

Hunters and trappers are the principal groups that will be affected by this rulemaking. These rules, and the legislation which grants the department rule-making authority, do not have a significant economic impact on the private sector or small businesses. These rules impose no compliance or reporting requirements for small business, nor are any design or operational standards contained in the rule.

7. Soliciting public input on economic impact synopsis

The department has determined that these rules will have no economic impact locally or statewide. The department posted a notice soliciting comments on this analysis on its website from August 13th through August 27th. No comments were received. A copy of the economic and fiscal impact analysis is attached as part of this agenda item.

8. Small Business Analysis

These rules, and the legislation which grants the department rule making authority, do not have a significant fiscal effect on the private sector or small businesses. These rules are applicable to individual sportspersons and impose no compliance or reporting requirements for small business, nor are any design or operational standards contained in the rule. Therefore, under s. 227.19 (3m) Stats., a final regulatory flexibility analysis is not required.

Appendix 1. 2021 Spring Hearing Questions.

WILDLIFE MANAGEMENT PROPOSED RULE CHANGES

1. Allow falconry to take place on the Richard Bong State Recreation Area after the 2 p.m. closure.

Falconry is a unique sport that has a low or no impact on other activities. Due to Bong's popular managed pheasant hunting program (8,770 average annual pheasant hunters from 2015- 19) and high number of falconers have stopped practicing their sport during legal hunting hours due to safety concerns of the falcons used. Due to the nature of pheasant hunting, falconry birds are at a high risk of being mistaken for pheasants while partaking in their sport. This proposed change will specifically allow falconry hunting on the Bong property after the 2p.m. hunting closure to ensure a safe continuation of the sport. At this time two hunting activities are allowed after 2p.m. (waterfowl and bow deer), this proposal would add falconry as a third.

2. Increase the time that cable restraints are allowed during regulated trapping seasons.

Currently, trappers cannot use cable restraints until December 1st. This proposal would allow the use of cable restraints beginning on the dryland trapping opener (Saturday nearest October 17th) for bobcat, fox and coyote. A study evaluated the use of cable restraints on dryland was conducted in Wisconsin from 2001-2002. Results of this study resulted in new regulations allowing the use of cable restraints on dryland from Dec 1st – Feb 15th for fox, coyote and bobcat. The start date of December 1st was chosen to avoid any incidents involving the new cable restraint and other hunting dogs in the months of October and November. A review of previous trap incident reports involving cable restraints has confirmed this tool is selective and doesn't pose a threat to domestic dogs.

3. Return to a three-zone framework for mink and muskrats.

In 2014, as part of a larger rule simplification effort, the department switched to a one zone, one opening day format for managing muskrat and mink. This resulted in earlier opening dates in the central and southern zones and a uniform end date (beginning on the Saturday nearest October 25 and continuing through the Sunday nearest March 7). Prior to this simplification, the department had managed mink and muskrats through multiple harvest zones. At one time, the muskrat and mink season framework included

a north zone, central zone and south zone all having progressively later starting dates. Additionally, there were at least two local zones with later closing dates. There is a segment of the trapping community requesting a return to a three-zone (plus Mississippi) system and extend the spring season.

Below is the suggested framework change:

- 1) To return to three zones (plus Mississippi Zone).
- 2) The south zone should open on the Saturday on, or the first Saturday following November 1, and should close on March 15.
- 3) The Central zone should open on the Saturday on, or the first Saturday following October 25, and should close on March 22.
- 4) The Northern zone should open on the Saturday on, or the first Saturday following October 18, and should close on April 15.
- 5) Maintain current Mississippi zone including start and close dates (beginning on the second Monday in November or the day after the close of the duck season in the Mississippi River Zone, whichever occurs first, and ending on the Sunday nearest March 15).

4. Allow the department to regulate target shooting on department properties in Columbia County

Currently target shooting is unregulated on DNR owned lands unless these lands are in counties listed ch. NR 45.09(5), Wis. Adm. Code. Prior to the opening of a public shooting range at the Mud Lake Wildlife Area in 2018, problems existed regarding target shooting on state lands in Columbia County, including littering and bullets ricocheting into inhabited areas. Local support was resistant to closing properties until a public range could be built. The state secured funding for a public range and the range has been open to the public since 2018. However, even after the opening of the new range, vandalism and littering is still

taking place from individuals target shooting on nearby state lands. Closing the remainder of state-owned properties to target shooting would funnel those activities to the public range.

5. Extend the date of the gray and fox squirrel seasons.

Currently, hunting season for gray and fox squirrels opens on the second Saturday of September and closes on January 31st. This regulation change would keep the original start date of the second Saturday in September but extend the season to be open through the last day of February. This proposal would potentially simplify the closing dates for small mammal hunting by synchronizing the season closure date of squirrels with the that of cottontail rabbits.

ORDER OF THE STATE OF WISCONSIN NATURAL RESOURCES BOARD AMENDING, REPEALING AND RECREATING AND CREATING RULES

The Wisconsin Natural Resources Board proposes an order to **amend** NR 10.01 (3) (a) 1., 10.13 (1) (b) 15., 10.24 (6) (d) and 45.09 (5) (intro); to **repeal and recreate** NR 10.01 (4) (a) and (d); and to **create** NR 10.39 relating to the 2021 Wildlife Management spring hearing rule related to hunting, trapping, and target shooting.

WM-18-20

Analysis Prepared by the Department of Natural Resources

1. Statute Interpreted: In promulgating this rule, s. 29.014, Stats., has been interpreted as providing the department the authority to establish seasons and bag limits while ensuring public hunting and recreational opportunities.

In addition, s. 23.11 & 23.09(2)(d), Stats., grants the department the authority to regulate outdoor recreational use on state lands.

- **2. Statutory Authority:** Statutes that authorize the promulgation of this rule order include ss. 29.014, 23.11, and 23.09(2)(d), Stats.
- **3. Explanation of Agency Authority:** The chapter on wild animals and plants, in s. 29.014, Stats., "rule making for this chapter", establishes that the department shall maintain open and closed seasons for fish and game and any limits, rest days, and conditions for taking fish and game.

The department is generally charged with the care, protection, and supervision of state lands by s. 23.11 Stats.

Under s. 23.09(2)(d), Stats., related to conservation, the department is directed to provide an adequate and flexible system for the use of outdoor resources in this state and may promulgate such rules as are necessary. These rules are necessary to preserve public opportunities to hunt with firearms on lands that have been acquired as areas where any citizen may hunt or trap.

4. Related Statutes or Rules: There are no currently active related administrative rules.

5. Plain Language Analysis:

SECTION 1 changes the closing of the gray and fox squirrel hunting season so it ends on the same day of the cottontail rabbit season.

SECTIONS 2 AND 5 create a three-zone framework for mink and muskrats.

SECTION 3 increases the time that cable restraints are allowed during regulated tapping seasons.

SECTION 4 allows falconry to take place on the Richard Bong State Recreation Area after the 2 p.m. closure.

SECTION 6 regulates shooting on DNR lands in Columbia County.

6. Summary of, and Comparison with, Existing or Proposed Federal Statutes and Regulations: Federal regulations allow states to manage the wildlife resources located within their boundaries provided they do not conflict with regulations established in the Federal Register. None of these rule changes violate or conflict with the provisions established in the Federal Code of Regulations.

No preliminary public hearing was required on the Statement of Scope for this rule.
